



Detter Family Foundation Leaders in Mathematics & Science Scholarship



Remembrance Ranch Transform Catering

We recently awarded a \$3,000 grant to **Remembrance Ranch Transform Catering** to purchase and provide the items necessary for the program. Transform Catering provides youth that are enrolled in Alternative Education, or GED Programs, an opportunity to learn and develop necessary skills to pursue a career in hospitality.

Remembrance Ranch has a strong partnership with Allendale Public Schools and most of the families and teens they serve are from the Allendale area. Transform Catering provides youth with a 20-week training program, as well as mentors to support participants of the program with resume and interview assistance at the completion of the program.

Supporting the Grand River Greenway

We are excited to announce a new community service fund supporting the Grand River Greenway! We are now accepting donations into the **Allendale Trail Fund – Phase 1 Fund**, a Community Service Fund that supports the construction and enhancements of phase one of the Allendale portion of the Grand River Greenway, a non-motorized path located in Allendale Township. The area includes the section of 60th Avenue from Lincoln south to where the sidewalk begins just north of Lake Michigan Drive.



The goal is to raise \$100,000 over the next three years to demonstrate community support and come alongside the Grand River Greenway project in a very proactive way. We already have donations and pledges from local business owners coming in. The total estimated cost for that section of trail is \$850,000.
