Community Foundation Announces New President





Prior to Centegra, she was the Manager of Strategic and Operational Consulting at Huron Consulting Group and Manager at PricewaterCoopers, LLC, both in Chicago. She has a Bachelor of Science from Miami University and a Master of Business Administration from the University of Georgia.



In 2016, Streng received the McHenry County Women of Distinction Award. She has also served with the McHenry County Economic Development Corporation and the Allocations Committee for the United Way of Greater McHenry County, and both graduated from and served on the board of Leadership Greater McHenry County, a program similar to the Chamber of Commerce Grand Haven, Spring Lake, Ferrysburg's Leadership Connect.
