## **Community Foundation Spring Grants**

This past spring, the Coopersville Area Community Foundation grants committee awarded two grants totaling \$3,200 to two area nonprofits.

The *Coopersville Area District Library* is working to meet a need in the Coopersville Community and the community foundation has jumped in to help. According to Elyshia Hoekstra, the library director, "There is a need for reliable Internet access in the wider Coopersville community. Due to changes brought about by the COVID pandemic, there is an even greater need for this reliable connection, as more and more people are working or taking classes virtually."

Katie VanHuis, the library assistant, adds, "I have seen patrons sit in our parking lot to use the WiFi. We know

the need is there, and we are grateful to have the ability to loan out these hotspots."

This huge need of reliable Internet access, for telehealth appointments to virtual classes and meetings, has become a vital undertaking the Coopersville Library is trying to improve for our community.

Additionally, the *Ottawa* 

*Community School Network* received \$1,200 for programming for children, ages 5-12, after school.


