Giving Grants

This last round, we awarded six Community Impact grants, totaling \$288,000!

Recipients include:

The Outdoor Discovery Center – \$68,000 to assist with summer programming in partnership with Grand Haven Area Public Schools.

Trinity Health Grand Haven Hospital – \$40,000 for a telemedicine robot required for their goal of becoming a certified Primary Stroke Center.

Pine Rest Pediatric Center for Behavioral Health – \$100,000 toward the building of the new center to improve access to mental health services for children and adolescents.

Children's Advocacy Center – \$30,000 for their medical exam suite renovation, which will make it as child-friendly, warm, and accessible as possible.

Grand Valley State University – \$50,000 to establish a postdoctoral fellowship program at the Robert B. Annis Water Resources Institute to conduct critical research on local aquatic ecosystems.
